

FEE SCHEDULE

GROUP DEFINITIONS

Rev. Aug 2008

Exempt

Groups that have a direct affiliation with L'Anse Creuse Public Schools, or are formed for the health and welfare of students or employees of the L'Anse Creuse Public Schools.

- A building rental fee will not be charged to Exempt users, including, but not limited to: School/District-sponsored activities or events, school athletic/intramural activities, groups organized through Community Education, student clubs/enrichment, PTA/PTO/Boosters, staff groups for professional development purposes.
- Exempt users will be billed for labor costs incurred by the District for additional work beyond the normal custodial schedule.
- At the discretion of the Business Office, additional charges may be incurred for extenuating services, or contracted services such as additional trash dumpster or portable restroom facilities.

Group I

Youth and Nationally-Recognized organizations that serve the district youth and/or adult residents of L'Anse Creuse Public Schools.

- Discounted building rental fees will apply to Group I users as described in the Fee Schedule, including, but not limited to: Youth and Nationally-Recognized organizations, located in the L'Anse Creuse Public Schools attendance area, such as, AYSO and Little League.
- Group I users will be billed for all labor costs incurred by the District for additional work beyond the normal custodial schedule.
- At the discretion of the Business Office, additional charges may be incurred for extenuating services, or contracted services such as additional trash dumpster or portable restroom facilities.

Employee Discount

L'Anse Creuse Public Schools, as a courtesy to district employees, will offer an Employee Discount at the Group II rate, where no other rate application applies and when in service to the staff or community. Employee discount is at the discretion of the LCPS Business Office. Application fees will not apply.

Group II

Government Entity, Non-Profit School/Hospital, Church and Religious Education, Homeowner/Residential Associations, Neighborhood Recreation Groups, Non-Profit Section 501c(3) or 501c(4) Organizations.

Discounted building rental fees will apply to Group II users as described in the Fee Schedule, including, but not limited to: Government Entity, Non-Profit School/Hospital, Church and Religious Education, Homeowner/Residential Associations, Neighborhood Recreation Groups, Non-Profit Section 501c(3) or 501c(4) Organizations.

- Parks and Recreations programs, not organized through LCPS Community Education, will be granted use at the discretion of LCPS Community Education and subject to Group II rates.
- Homeowner Associations must be located within the LCPS attendance area to qualify for Group II discount. Proof of residency may be required.
- Group II users will be billed for all labor costs incurred by the District for additional work beyond the normal custodial schedule.
- At the discretion of the Business Office, additional charges may be incurred for extenuating services, or contracted services such as additional trash dumpster or portable restroom facilities.

Group III

Non-Public School, Service and Community Groups Charging Fees, Private Groups, For-Profit Individuals/Groups/Organizations.

- Building rental fees will apply to Group III users as described in the Fee Schedule, including, but not limited to: All organizations that charge admission fees, and private groups offering membership, lessons, or charging for services.
- LCPS reserves the right to negotiate services/fees for Group III users, on individual lease or contract, by mutual agreement between LCPS and the user, at the total discretion of L'Anse Creuse Public Schools.
- Group III users will be billed for all labor costs incurred by the District for additional work beyond the normal custodial schedule.
- At the discretion of the Business Office, additional charges may be incurred for extenuating services, or contracted services such as additional trash dumpster or portable restroom facilities.

LCPS reserves the right to negotiate services/fees for users, by individual lease or contract, by mutual agreement between LCPS and the user, at the total discretion of L'Anse Creuse Public Schools.
