F. Superintendent's Report

F.1. Mr. Edoff welcomed Mr. Cyprus to the Board of Education and stated he looks forward to his ideas to enhance programs and student experiences.

Mr. Edoff thanked the L'Anse Creuse staff for their work with students every day. He reminded everyone that teaching and learning is the district's focus, however when social media and the internet become a part of the school environment, it creates a negative distraction. He shared he is planning for next year and will be addressing the physical, academic and instructional needs in the district. Mr. Edoff stated that it is important to center on what is best for students and the district will be seeking input from stakeholders on projects and what is needed.

Mr. Edoff thanked the Business Department for a successful audit and their work in protecting district funds. He also thanked the Curriculum Department and stated the district will have long-term benefits due to their efforts and work on the budget.

Dr. Spencer addressed the Board regarding the need to follow up on a recent policy recommendation to address when a complaint is made about a board member or employee. She asked that the Board follow through on the discussion.

Mrs. Servial addressed the Board and public regarding recent election issues that have been occurring in the district with election signs being tampered with, and expressed the need for these actions to be reported.

Mr. Sellers thanked Coach Orande Roy and Athletic Coordinator Ryan Stocker at L'Anse Creuse High School for the recent football game between L'Anse Creuse High School and L'Anse Creuse High School – North, sharing that it showcased the best of the district.

Mr. Cyprus thanked everyone for their support and stated he hopes to make a positive impact during the short time he has on the Board. He encouraged everyone to vote on Election Day, and informed everyone he is now running as a write in candidate for the L'Anse Creuse Board of Education.

Dr. Spencer thanked the Business and Curriculum Office for the audit and welcomed Mr. Cyprus to the Board.

Mr. Lipski thanked the Business Office for the audit and shared how far the district has come with the fund balance over the last four years. He stated that the election is very important to the Board and reminded everyone to vote.

Mrs. Ross thanked the Business and Curriculum Offices for their work on the audit and addressed the election sign issue occurring in the district.
