NAMING AND DEDICATION OF FACILITIES/HALL OF DISTINCTION

Naming Facilities in Honor of a Prominent Individuals

School Buildings and facilities such as; auditoriums, gymnasiums, athletic fields, multi-purpose rooms, media centers or nature centers, may be named in honor of prominent persons who have made significant contributions to the purposes of education or to the community at large. In the event a school building or facility may be named after a district employee or member for the Board of Education, the naming process shall begin only after the person has been separated from the district for a minimum of one year. When deemed appropriate, this provision can be waived by a majority vote of the Board of Education.

Hall of Distinction Honorees

Hall of Distinction Honorees are individuals who have made significant contributions to the district who have not been recognized by other means, and to provide a tangible means of presenting the history of the district to the general public.

Proposals

Proposals to name a school building or facility or to nominate a Hall of Distinction Honoree must reflect broad community and/or site-based involvement, and the process prescribed herein must be followed in full. The process is as follows:

- 1. An ad hoc committee initiates a written proposal and submits the proposal to the Superintendent or designee by May 15.
- 2. The proposal is forwarded to the District Naming/Nominating Committee.
- 3. The District Naming/Nominating Committee evaluates the proposal(s).
- 4. The District Naming/Nominating Committee makes a recommendation to the Superintendent.
- 5. Final approval of all names of school buildings and facilities and Hall of Distinction Honorees rests solely with the Board of Education.
- 6. The Hall of Distinction ceremony will be scheduled in early fall, naming of facilities or schools ceremonies will be schedule as appropriate for the facility/building.

Ad Hoc Committee

An individual or group may form an ad hoc committee to propose a name for part or all of a school building or facility or to nominate a Hall of Distinction Honoree. The proposal may be secured from

the Superintendent's office. Completed proposals are returned to the Superintendent's office and then forwarded to the District Naming/Nominating Committee.

The <u>proposal for the naming of a school building or facility</u> submitted by the ad hoc committee must be completed utilizing the format in the attached forms (Attachment A), with rationale in all of the following categories:

- 1. Significant contributions to school/community
- 2. Outstanding personal/professional characteristics
- 3. Years of service to L'Anse Creuse Community (if applicable)
- 4. Professional/community affiliations
- 5. Educational impact on students/staff/community
- 6. Relevant association to school building or facility to be named

Letters in support of the naming, addressing the criteria above, are required from:

- 1. Students (minimum of two letters)
- 2. Staff (minimum of two letters)
- 3. Community (minimum of two letters)

Expenses incurred in the naming of a school building or facility shall be identified and may become the responsibility of the ad hoc committee. A proposed budget (Form 2) shall be submitted with the naming proposal. The naming proposal shall be submitted to the District Naming Committee for evaluation.

The <u>proposals for the nomination of a Hall of Distinction Honoree</u> submitted by the ad hoc committee must be completed utilizing the format on the attached forms (Attachment B) with rationale in all of the following categories:

- 1. Significant contributions to school/community and their support to a meaningful and fulfilling education for students
- 2. Outstanding personal/professional characteristics
- 3. Contributions above and beyond position

Letters in support of the nomination for the Hall of Distinction Honoree, addressing the criteria above, are required from:

- 1. Current or former L'Anse Creuse supervisor or colleague
- 2. Current or former student or parent of student
- 3. Other letter(s) of support

Expenses incurred in the nomination of a Hall of Distinction Honoree shall be the responsibility of the ad hoc committee (estimated at \$250).

District Naming/Nominating Committee

The District Naming/Nominating Committee shall be appointed by the Superintendent of Schools and composed of a representative from each of the following (Attachment C): the Curriculum Department; the Human Resources Department; the Business Department; building administration; non-administrative employees and the community.

The District Naming/Nominating Committee convenes to verify that the process has been completed in full. The District Naming/Nominating Committee evaluates the proposal(s) and makes recommendation to the Superintendent. The District Naming/Nominating Committee is dissolved after the process is completed for a specific proposal.
