Community Action Centers

Our three Community Action Centers offer emergency support services, information and referrals to Macomb County's limited-income residents. Community Action Centers also serve as intake points for several programs and services.

Community Development (586) 466-6256

Community Development oversees federallyfunded programs that are designed to meet certain specific needs of residents, particularly those who are low-income.

Head Start 0-5 (586) 469-5215

Head Start 0-5 is a free early childhood development and education program for incomeeligible families. The program provides a range services for pregnant women and families with children ages 0-5. Applications are accepted year-round.

Home Preservation/Energy (586) 469-6329

Macomb County residents are assisted with weatherization improvements that help to reduce energy use and lower utility costs. Landlords may also participate in the program (cost sharing required for landlords).

Individual Development Account (IDA) Program (586) 469-7378

The IDA Program helps eligible people purchase their first home. Participants' monthly deposits into a savings account are matched. The combined funds are used toward down payment and closing costs. Participants must also complete money management and home ownership seminars.

Macomb Food Program (586) 469-6004 For help with food call: 2-1-1

Macomb County residents with an urgent need are provided with food. People requesting emergency food are referred to a pantry near their home. Food is donated and distributed through the efforts of volunteers, church groups, businesses and concerned citizens.

Transportation (586) 469-5225

Eligible Macomb County residents are provided rides to physician visits, dialysis, and other specific locations. Riders are encouraged to make cost sharing contributions for the service.

Office of Senior Services (586) 469-5228

Adult Day Service provides daytime assistance for aging adults in need of structured activities, exercise and supervision.

Chore Service provides grass cutting, snow removal, and minor home maintenance for eligible Macomb County senior citizens in order to help them remain independent in their homes.

Dining Senior Style offers hot lunchtime meals and social opportunities for people over 60. Sites are located throughout Macomb County. A permeal cost share contribution is encouraged.

Home Injury Control is a one-time service provided to handicapped and frail Macomb County senior citizens to prevent falls and injuries in the home. Safety devices include bathtub grab bars, bathtub chairs, and handrails.

Loan Closet provides used small medical equipment, such as wheelchairs, bath benches and walkers for Macomb County seniors. Donations of used equipment are accepted.

Meals on Wheels delivers hot lunchtime meals to homebound senior citizens Monday through Friday. A per-meal cost sharing contribution is encouraged. Volunteer drivers are always needed.

Project Fresh provides coupons to eligible seniors during summer months to buy fresh produce at local farmers' markets.

Resource Advocacy is part of a county-wide team which provides consultation for seniors to assess needs, recommend services and assist with:

- Tax credits
- Medicaid application process
- Medicare Part D enrollment
- Community resources
