SCHOOL DRIVING AND PARKING REGULATIONS

- 1. LCN Students must be in 11th or 12th grade and have a Level 2 or Level 3 Graduated Driver's License to apply for a Parking Permit.
- 2. All motor vehicles on school grounds must be registered with the school and must display a current parking permit sticker in the window facing out.
- 3. Replacement of lost permits are \$35. Each student may purchase a sticker for one parking space. A maximum of two vehicles may be assigned to the space. Additional vehicles must be replacements and there is a \$10 fee for each vehicle.
- 4. Students who have not purchased a personalized parking spot that make the poor choice to park in another student's personalized spot can be subject to disciplinary action, may have their vehicle towed, and/or may have their parking privileges revoked.
- 5. Students may not go to their cars during school time without permission from a school administrator. Violation of this regulation may mean school discipline and/or revocation of parking privileges.
- 6. Students' vehicles may be subject to search if there is "reasonable suspicion" to suspect drugs, tobacco, alcohol, weapons, stolen property, or other contraband that may be present in the vehicle that violates the Student Code of Conduct. Tobacco and vape products are a violation of the Student Code of Conduct even if the owner of the vehicle is over the age of 18, and thus subject the student to disciplinary action and possible revocation of parking privileges.
- 7. Macomb Township Ordinance #18 (no parking ordinance) and the school parking regulations, parking within the lines, observing a 5 MPH speed limit, cooperating with security guard(s), safe and courteous driving at all times and observing posted signs will be strictly enforced. Suspension or total loss of driving privileges, ticketing by the police, or towing of vehicles and/or suspension from school may result if violation of these regulations occur.
- 8. Students enrolled in the Early College, Dual Enrollment, or any online learning or other similar programs must sign out upon departure.
- 9. Leaving campus for lunch or other reasons without parent permission and an early dismissal pass is strictly forbidden. School discipline and permanent loss of parking privileges may result.
- 10. Students park at their own risk. The school will not be responsible for vandalism, damage, or theft. For students' protection, doors and windows MUST be locked while vehicle in on school property.
- 11. If a student begins to accumulate excessive absences or tardies in their first hour class because of driving to school, their parking permit may either be suspended or revoked.
- 12. SHARING OR SELLING OF TAGS TO OTHERS MAY RESULT IN SCHOOL DISCIPLINE AND/OR LOSS OF PRIVILEGES NO REFUNDS!
- 13. Students may not park in designated visitor's parking spaces, other students' designated spaces or operate/park their vehicles in the staff parking lot at any time.
- 14. The district provides transportation between HSN and Pankow for specific programs and classes schools during the school day, therefore students are prohibited from driving a vehicle between schools unless permission is granted by a building administrator or designee. It is understood that a violation of any of the driving and parking regulations may result in the suspension or loss of this privilege.
